From South Carolina: Interstate 85 Exit 177 Elberton/Hartwell turn left off ramp onto GA 77 South for approximately 7 miles (just past Cross Roads Baptist Church) turn right onto Airline School Rd for ~1.8 miles, cross GA 51 onto Airline Goldmine Rd (watch road signs and stay on Airline Goldmine) for ~1.7 miles field on the right.

From Atlanta: Interstate 85 Exit 173 Lavonia, Turn right onto Jones St (signs for Lavonia/Hartwell/Royston). Continue onto GA-17 S / Augusta Rd for 4.9 miles, turn left onto GA 51 E /Scheafer St for 1.8 miles. Turn right onto Whitewood Rd for ~1.3 miles then slight right onto Airline Goldmine Rd for 0.7 miles and field will be on the right.

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis and Whippets may be entered in the regular stakes.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

REGULAR STAKES OFFERED

OPEN STAKE: Any non-Field Champion hound previously entered in the Open Stake.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. No "first time entered" hounds shall be permitted in the Singles Stake at a Regional Invitational.

NON-REGULAR STAKES OFFERED

On Saturday, September 16, 2017 for Regional Invitational

BENCH STAKE: For any sighthound with proof on file with the ASFA of a conformation champion title from the AKC, CKC or both or a conformation grand champion title for the UKC. To enter this stake, the owner must attach a copy of the hound's show championship certificate to the entry form.

BREEDER STAKE: For any breed which shall have, designated at the time of entry, two hounds bred by the same individual.

KENNEL STAKE; For hound of any individual breeds; an entry shall consist of two hounds designated at the time of entry, in one of the regular stakes being owned and kenneled by the same person.

Hounds entered in the Single Stake are not eligible to be entered in Breeder, Kennel or Bench Stakes.

ADDITIONAL ELIGIBILITY for REGION 7 INVITATIONAL ONLY

No Day of Trial Entries. No First Time Entries. Regional Invitational Requirements any hound that has earned at least one ASFA point is eligible to enter. For a Limited Stake to be eligible, the entered hound must have received a placement with competition. All points or placements must be earned by the closing date of the event. Any hound entered in the Single Stakes does not need prior ASFA experience. An eligible hound may be entered in any number of Regional Invitationals.

Conditions of Entry: This applies to the CLCS SUNDAY TRIAL ONLY: All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
